#### **The Mental Health Productivity Commission**

The Mental Health Productivity Commission Inquiry received over 500 submissions from individuals and organisations. Prior to the election the current Government made promises to implement the full raft of recommendations when they are made apparent on the 23 May 2020. This undertaking is currently underpinned by a commitment to spending 4.8 billion on mental health services, which can be compared to the 9.1 billion that the 2016-2017 expenditure on mental health cost Government and non-government combined, according to the Mental Health Australia organisation the funding is insufficient given the scale of need. Recent recognition by the World Health Authority of the need to reduce the burden of mental illness worldwide is a reminder that mental illness poses enduring problems on a global scale in terms of productivity and wellbeing.

Relationship organisations such as Better Place Australia and Relationships Australia as well as Legal Aid and the Law Council of Australia have identified a bi-directional relationship between poor family relationships and mental ill health and have highlighted the social and economic benefits to broader society regarding supporting mental health in the community.

Legal issues are a known contributing factor to mental health stressors in adults and families, this connection has been further identified in the youth population where legal

issues are a key predictor of mental health decline. In cases of Family Law, some Relationship Centres utilize the FL-DOORS model (Family Law Detection of Overall Risk Screen) which is a three-part framework that assists separating parents and family law professionals to detect risk at client point of entry and provide pathways towards a co-ordinated response to mitigate mental health stress and assist in determining safety decisions regarding risk of suicide, domestic violence and child safety. Family Relationship centres and Legal organisations suggest professionals working with clients in distress detect risk at client point of entry and provide pathways to an effective and co-ordinated response.

Legal and Relationship Centres clarified the relationship between financial insecurity and mental stress, many risk factors for developing mental illness are associated with social inequalities. Legal Aid has highlighted Australia's manifestly inadequate affordable housing availability on top of diminishing social security payments for those in need of disability support pensions who are currently relying on Newstart payments due to changes in the impairment tables setting out DSP qualification criteria. ACOSS points out that Newstart is well below the Henderson Poverty Line and cannot adequately support long term welfare recipients. The Centrelink debt recovery system which has raised 77,500 incorrect Centrelink debts against recipients has also been red flagged as a system which actively undermines community wellbeing within vulnerable demographics in Australia.


The Law Council of Australia has drawn attention to the prevalence of mental health issues within the legal sector including depression, anxiety, alcohol and drug misuse in rates higher than the general population. These problems co-occur with overcommitment as a contributing cause of psychological stress. Mitigating such workplace mental health issues could include introducing mental health first aid programs as compulsory workplace initiatives under relevant legislation, amongst a raft of many other progressive suggestions.

Better Place Australia has called for mental health services to be aligned with the Family Law System, perhaps similarly to the Assessment & Referral Court initiative, to ensure awareness of both the potential and availability of supports for those who are vulnerable or at risk of developing a mental health condition.
